FIRST AMENDMENT TO AFFILIATION AGREEMENT

THIS FIRST AMENDMENT TO THE AFFILIATION AGREEMENT (this “**First Amendment**”) is entered into by and between **THE MEDICAL COLLEGE OF WISCONSIN, INC.** (“**MCW**”) and Princess of Naradihiwas University (“**PNU**”), Faculty of medicine. The Facility and the School may be referred to herein as a “**Party**” and collectively as the “**Parties**”. This First Amendment shall be effective as of the date the last of the Parties executes this First Amendment (the “**First Amendment Effective Date**”).

Recitals

- A. The Parties entered into a Affiliation Agreement effective December 5, 2014 (the “**Agreement**”).
- B. The Parties now wish to amend the Agreement in accordance with the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained in this Amendment, the Parties agree as follows:

1. The term of the Agreement set forth in Section 5.1 is hereby extended for five (5) additional years commencing as of December 6, 2019 and terminating December 5, 2024.
2. Except as modified by this First Amendment, all terms and conditions of the Agreement remain unchanged and the Agreement shall remain in full force and effect. The Agreement, as amended by this First Amendment, is hereby ratified and confirmed by the Parties.
3. The Parties agree that this First Amendment may be executed in multiple originals, each of which shall be considered an original for all purposes and, collectively, shall be considered to constitute this First Amendment. The Parties further agree that signatures transmitted by facsimile or in Portable Document Format (pdf) may be considered an original for all purposes, including, without limitation, the execution of this First Amendment.
